### **Tourist Requirements:**

1. Complete the application form
2. Two (2) passport sized (3.5"X4.5") photographs
3. Current and old passports
4. Employment certificate **showing your tenure, salary, position and approved leave**
5. If business owner, readable photocopy of your **business/mayor's permit and registration (SEC/DTI) certificate**
6. Bank certificate verifying the **current balance of your account(s)**
7. **3 months recent** bank statements and/or updated **passbook** showing a history of your account(s)
8. If family members are travelling with you, a readable copy of your marriage certificate and your children's birth certificates on Philippine Statistic Authority (PSA) security paper.,
9. If **spouse** employed, personal supporting documents same as above.
10. If **child** student evidence of enrollment and registration in school, copy of school I.D., form 1229 - Consent to grant an Australian visa to a child under the age of 18 years, form 1257 - Undertaking declaration, parent's supporting documents same as above.
11. If you are traveling in order to **visit a friend** in Australia,
  - a. A letter of invitation with a statement indicating the **nature of your relationship** and **details of how, when and where you first met.**
  - b. If your friend paying for your visit, evidence that they have the necessary funds to pay/support for your visit.
  - c. Copy of invitees Passport and (visa if applicable)
12. If you are traveling in order to **visit a relative** in Australia,
  - a. **Letter of invitation and statutory declaration** from your relative
  - b. Evidence that they have the necessary funds to pay/support for your visit.
  - c. Copy of invitees Passport and (visa if applicable)

### **Additional requirements:**

**Organised group tours:** Covering letter from the tour organizer, including the full itinerary and purpose of the tour, and a list of all participants.

**Non-Filipino Nationals:** Residing in the Philippines: Evidence of their visa status or residence in the Philippines, including their right to return.

**Applicants 75 years old or over:** Receipt showing that they have undergone a medical examination from one of the approved panel doctors (after filing, wait for the embassy referral letter) and Travel Insurance which will cover medical expenses for the full stay in Australia.

**Applicants intending to visit Australia for more than 3 months (11 years or older):** A receipt showing that they have undergone a chest x-ray from one of the approved panel doctors (after filing, wait for the embassy referral letter) and Travel Insurance, which will cover medical expenses for the full stay in Australia. (2.5M or higher coverage policy.)
